3. Failing this and ignoring any contact in relation to outstanding debit, your account will be handed over to a debt collection agency.
4. Clients for whom a full and final payment has not been made by December 1st, may find the learner's place has been forfeited for the following year, and progress reports will not be issued by Future Education Centre.
5. Future Education Centre reserves the right to suspend tutoring for any student if the account is in arrears and arrangements have not been made. Future Education Centre is primarily a business and the suspension of tuition does not in any form reflect the withholding of education from a student.
6. Future Education Centre may withhold documentation, such as transfer information, examination results, and any other property deemed to be that of Future Education Centre, until all amounts owing have been paid.
